Hazardous Nature:

Skin Contact:

In case of skin contact, immediately remove contaminated clothing and wash affected areas with water and soap. Seek medical attention if irritation develops and persists.

Eye Contact:

In case of eye contact, rinse with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing for at least 15 minutes. Seek medical attention if irritation persists.

Ingestion:

If swallowed, do not induce vomiting. Immediately rinse mouth with water. Give a glass of water to drink in small sips. Never give anything by mouth to an unconscious person. Seek immediate medical attention.

Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so and sweep granules into a pile and shovel into drums for subsequent disposal. Avoid generating dust. Provide adequate ventilation. Decontaminate spill area with detergent and water.

7 Handling and Storage

Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of dust.

Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.

Conditions for Safe Storage:

Store in a cool, dry and well ventilated area. Keep container tightly closed when not in use. Do not store for prolonged periods in direct sunlight. Protect from heat, sparks, open flames and other sources of ignition. Keep away from strong oxidising agents.
